He could not understand why he had lost out on four large construction contracts that he had been invited to bid. His profit had been pared to the minimum. A competitive firm had managed to underbid him by a small amount each time, just enough to obtain the jobs.

Instead of ending the game of industrial espionage then and there, it was decided to let the informant perform an act of poetic justice. False figures on the next large job were prepared, which were in turn leaked to the rival concern by the informant. At the last minute, before the bid figures were submitted, and without the knowledge of the dishonest employee, the figures were changed and it is not difficult to deduce who got the job. The president of the rival firm is still wondering how his lifeline to the other contractor had been cut.

WIRETAPPING

Industrial espionage is on the upswing, nationally, and the methods employed by the corporate cloak and dagger set are as intriguing as those used by the spies and saboteurs during the last war.

The tools of the trade are exotic, but one tool that is frequently resorted to, is wiretapping. True, wiretapping is illegal in almost every jurisdiction, and it cannot be introduced as evidence in most courts, but that does not deter the noble warriors; it just increases their asking price. When there are immense profits at stake, there are immense risks taken.

There are two basic wiretapping techniques in use today. The first is with an automatic recorder, which preserves all conversations for future monitoring. The device is actuated in one of three ways. One technique relies upon a voltage relay, since the voltage drops when the phone is in use. Another method of actuating an automatic recorder is via the audio route, where the electronic attachment senses the conversation and starts recording. The third method is called series actuation, and when this is employed, the actual current of the line is diverted and flows through the actuating unit. Utilizing one of the above three actuating techniques, the automatic recorder tapes the conversations, which are later monitored for useful tidbits.

The other basic wiretapping technique is to use a transmitting tap. An operator who acts, dresses, and talks like a lineman appears on the corporate scene. Frequently, his cronies have rendered one of the trunk lines inoperative to give him an excuse to appear on the premises at the invitation of the corporation. He carries the conventional tools of the lineman's trade. Under the guise of locating the trouble, he locates the proper person's line. He fixes the defective line, but also manages to make the transmitting tap, which broadcasts the conversations on a 30-50 megacycle band, to a nearby auto or panel truck.

Many business executives are under the misimpression that a private telephone line, divorced from the main trunk lines, will give them more privacy and render their talk less vulnerable to interception. The fact is, though, that private lines are among the easiest to tap. It is usually prohibitively expensive to tap and monitor a trunk line, but with comparative ease, a private line can be located and the stream of communications monitored economically. A residence is also relatively easy to tap, since there is just a drop line, a pole, and a terminal box to contend with, except in some residential sections where the cables have been installed underground.

To Stop A Thief
